12 MANAGEMENT ASSOCIATION MISCELLANEOUS
13 EMPLOYEES TO THE CALIFORNIA PUBLIC EMPLOYEES'
14 RETIREMENT SYSTEM (CalPERS)

15 WHEREAS, the City of Long Beach has the authority to implement
16 Government Code Section 20636(c)(4) pursuant to Section 20691; and

17 WHEREAS, the City of Long Beach has a written labor policy or
18 agreement which specifically provides for the normal member contributions to be paid
19 by the employer, and reported as special compensation; and

20 WHEREAS, one of the steps in the procedures to implement this section
21 is the adoption by the governing body of the City of Long Beach of a resolution giving
22 notice of its intention to commence reporting the value of employer paid member
23 contributions (EPMC) as compensation for all members of the group or class as
24 identified herein.

25 NOW, THEREFORE, the City Council of the City of Long Beach resolves

Section 1. Effective as of September 18, 2004, the governing body of the City of Long Beach shall implement Government Code Section 20636(c)(4) pursuant to Section 20691 by paying and reporting the value of Employer Paid Member Contributions (EPMC) for all unrepresented management employees paid pursuant to Executive Salary Rates (EEO) of the City's Salary Schedule and the City Attorney, City Auditor, City Prosecutor, City Manager, City Clerk and miscellaneous employees represented by the Long Beach Management Association. This benefit shall consist of the City paying 7% of the normal contributions as EPMC, and reporting the same percent value of compensation earnable, excluding special compensation pursuant to Government Code Section 20636(c)(4) as additional compensation. The employee shall pay 1% of the normal contribution.

Sec. 2. This resolution shall take effect immediately upon its adoption by the City Council, and the City Clerk shall certify to the vote adopting this resolution.




