3 THIS FIFTH AMENDMENT TO AGREEMENT NO. 33883 is made and
4 entered, in duplicate, as of April 6, 2021 for reference purposes only, pursuant to a minute
5 order adopted by the City Council of the City of Long Beach at its meeting on August 11,
6 2020, by and between KNN PUBLIC FINANCE, LLC, a California limited liability company
7 ("Consultant"), with a place of business at 5901 W. Century Blvd., Suite 750, Los Angeles,
8 California 90045, and the CITY OF LONG BEACH, a municipal corporation ("City").

9 WHEREAS, City and Consultant (the "Parties") entered into Agreement No.
10 33883 (the "Agreement") whereby Consultant agreed to provide financial advisory
11 services; and

12 WHEREAS, the Parties entered into a First Amendment to the Agreement to
13 extend the term to May 31, 2018; and

14 WHEREAS, the Parties entered into a Second Amendment to the Agreement
15 to extend the term to May 31, 2019; and

16 WHEREAS, the Parties entered into a Third Amendment to the Agreement
17 to extend the term to May 31, 2020; and

18 WHEREAS, the Parties entered into a Fourth Amendment to the Agreement
19 to extend the term to May 31, 2021; and

20 WHEREAS, the Parties desire to extend the term one (1) additional one year
21 period;

22 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
23 conditions herein contained, the Parties agree as follows:

24 1. Section 2 of the Agreement is hereby amended to read as follows.

25 "2. TERM. The term of this Agreement shall commence at midnight on
26 June 1, 2015, and shall terminate at 11:59 p.m. on May 31, 2022, unless sooner terminated
27 or extended as provided in this Agreement, or unless the services are completed sooner."
