FIRST AMENDMENT TO AGREEMENT NO. 35982

THIS FIRST AMENDMENT TO AGREEMENT NO. 35982 is made and entered, in duplicate, as of July 26, 2022, for reference purposes only, pursuant to Resolution No. RES-21-0061, adopted by the City Council of the City of Long Beach at its meeting on June 15, 2021, by and between THE BROADBAND GROUP, a Nevada corporation ("Consultant"), with a place of business at 900 South Pavilion Center Drive, Suite 155, Las Vegas, Nevada 89144, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 35982 (the "Agreement") whereby Consultant agreed to support in the preparation of the Citywide Fiber Network Infrastructure Initiative through fiber field audits, engineering plans, and construction bid preparations; and

WHEREAS, the Parties desire to extend the term one (1) additional one-year period;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

1. Section 2 of the Agreement is hereby amended to read as follows:

"2. TERM. The term of this Agreement shall commence at midnight on August 1, 2021, and shall terminate at 11:59 p.m. on July 31, 2023, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner. The term may be extended for one (1) additional one-year period, at the discretion of the City Manager."

2. Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 35982 are ratified and confirmed and shall remain in full force and effect.
