The Alameda Corridor



- 20-Mile – 40 m.p.h. Rail Corridor
- Consolidates 4 Branch Lines (10 m.p.h.)
- Reduced Conflicts at 200 Grade Crossings
- 10-Mile Trench Section
- 4 Million Cubic Yards Excavation
- 50 Grade Separations and Bridges
- 2,000 Utility Interfaces
- Nearly 100 Miles of New Track with CTC



ACTA Policy on Homeless Encampments

ACTA's Board established a policy to move people out of an area along the Corridor if:

- 1. there is a danger to the homeless individuals due to train operations or**
- 2. if the encampments are disruptive to the operations of the Alameda Corridor.**
 - a. This specifically is in regard to locations where homeless are residing adjacent to active railroad tracks.**

Supervisor Hahn then put forward a motion with the County Board of Supervisors in November 2017 to provide ACTA the opportunity to work with the County's Office of Homeless Initiative to develop a strategic plan to provide services for the individuals living in the encampments along the Alameda Corridor.
