

1 SECOND AMENDMENT TO AGREEMENT NO. 35370

3 THIS SECOND AMENDMENT TO AGREEMENT NO. 35370 is made and
4 entered, in duplicate, as of February 13, 2023, for reference purposes only, pursuant to a
5 minute order adopted by the City Council of the City of Long Beach at its meeting on
6 September 10, 2019, by and between REHAB WEST, INC. a California corporation
7 ("Rehab West"), with principal offices at 277 Rancheros Drive, Suite 370, San Marcos,
8 California 92069, and the CITY OF LONG BEACH, a California municipal corporation
9 ("City").

10 WHEREAS, City and Rehab West (the "Parties") entered into Agreement No.
11 35370 (the "Agreement") whereby Rehab West agreed to provide managed care services,
12 including medical case management; and

13 WHEREAS, the Parties entered into a First Amendment to the Agreement to
14 extend the term one (1) additional one-year period to September 20, 2022; and

15 WHEREAS, the Parties desire to extend the term one (1) additional one-year
16 period to September 30, 2023

17 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
18 conditions herein contained, the Parties agree as follows:

19 1. Section 1 of the Agreement is hereby amended to read as follows:

20 "1. EFFECTIVE DATE AND TERM. This Agreement shall begin on
21 October 1, 2019 and shall end on September 30, 2023 (both days inclusive), unless
22 terminated earlier in accordance with Section 13. By mutual agreement and amendment
23 of this Agreement, the parties may extend the initial term for one (1) separate, consecutive
24 period of one year."

25 2. Except as expressly modified herein, all of the terms and conditions
26 contained in Agreement No. 35370 are ratified and confirmed and shall remain in full force
27 and effect.
