A RESOLUTION OF THE CITY COUNCIL OF THE
CITY OF LONG BEACH TO TEMPORARILY CLOSE AND
REMOVE FROM PUBLIC USE CERTAIN STREETS
ALLEYS, AND WALKWAYS IN THE CITY OF LONG BEACH
IN CONNECTION WITH THE CONDUCT OF THE 2017
FORMULA DRIFT PRO CHAMPIONSHIP

The City Council of the City of Long Beach resolves as follows:

Section 1. The City Council of the City of Long Beach finds and determines that the temporary closing of the streets, described herein, is necessary for the safety and protection of the participants and spectators in the 2017 Formula Drift Pro Championship to be held from March 31, 2017 through April 1, 2017.

Section 2. For the conduct of the 2017 Formula Drift Pro Championship, the following streets, alleys, and walkways are hereby temporarily closed for the periods stated:

- A. On March 31, 2017 through April 1, 2017 from 7:00 a.m. to 7:00 p.m., Seaside Way from Pine Avenue to eastern end of Seaside Way, Linden Avenue from Ocean Boulevard to Seaside Way, Marine Way from Locust Avenue to Collins Way, Atlantic Way from Ocean Boulevard to Seaside Way, Marine Way from Hart Place to eastern end, Linden Avenue, northbound and southbound from Shoreline Drive to Marina Parking lot, and Locust Avenue from Ocean Boulevard to Seaside Way.
- B. On March 31, 2017 through April 1, 2017 from 7:00 a.m. to 7:00 p.m., Shoreline Drive westbound from Ocean Boulevard and Alamitos intersection to Shoreline Village Drive.
 - C. On March 31, 2017 through April 1, 2017 from 7:00 a.m. to

7:00 p.m., Shoreline Drive eastbound from Shoreline Village Drive to Ocean Boulevard and Alamitos intersection.

D. On March 31, 2017 through April 1, 2017 from 7:00 a.m. to 7:00 p.m., walkway off of Seaside Way from Hart Place to the east end of Seaside Way.

Section 3. The temporary closing of the above streets, alleys, and walkways, for the times herein provided is necessary for the safety and protection of the participants and spectators in the 2017 Formula Drift Pro Championship and qualifying events to be held from March 31, 2017 through April 1, 2017, utilizing the streets described herein.

For the period March 31, 2017 through April 1, 2017 from 7:00 Section 4. a.m. to 7:00 p.m., the streets, alleys and walkways described in Section 2.A. are hereby withdrawn and removed from public use.

Section 5. For the period March 31, 2017 through April 1, 2017 from 7:00 a.m. to 7:00 p.m., the streets, alleys and walkways described in Section 2.B. are hereby withdrawn and removed from public use.

For the period March 31, 2017 through April 1, 2017 from 7:00 Section 6. a.m. to 7:00 p.m., the streets, alleys and walkways described in Section 2.C. are hereby withdrawn and removed from public use.

Section 7. For the period March 31, 2017 through April 1, 2017 from 7:00 a.m. to 7:00 p.m., the streets, alleys and walkways described in Section 2.D. are hereby withdrawn and removed from public use.

Section 8. The City Manager, or his designee, is authorized and directed to post notices of the intent to temporarily reduce lanes, close the streets, alleys, walkways described in Sections 2, 3, 4, 5, 6, and 7 above at least twenty-four (24) hours prior to the closure thereof.

Section 9. This resolution shall take effect immediately upon its adoption by the City Council, and the City Clerk shall certify the vote adopting this resolution.
