SECOND AMENDMENT TO AGREEMENT NO. 33729

THIS SECOND AMENDMENT TO AGREEMENT NO. 33729 is made and entered, in duplicate, as of February 14, 2017 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on December 2, 2014, by and between MICHAEL BAKER INTERNATIONAL, INC., a Pennsylvania corporation (formerly known as RBF CONSULTING, a California corporation), with a place of business at 14725 Alton Parkway, Irvine, California 92618 ("Consultant"), and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, the City requires specialized services requiring unique skills to be performed in connection with on-call planning consulting services; and

WHEREAS, City and Consultant (the "parties") entered into Agreement No. 33729 (the "Agreement") whereby Consultant agreed to provide these services; and

WHEREAS, the parties entered into a First Amendment to the Agreement to add \$400,000 for a total not to exceed amount of \$800,000; and

WHEREAS, the parties desire to extend the term for an additional one (1) year period;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the parties agree as follows:

- 1. Section 2 of the Agreement is hereby amended to read as follows:
- "2. <u>TERM</u>. The term of this Agreement shall commence at midnight on January 1, 2015, and shall terminate at 11:59 p.m. on December 31, 2017, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner. The parties have the option to extend the term one (1) additional one-year period."
- Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 33729 are ratified and confirmed and shall remain in full force and effect.
