

GRANT AMENDMENT – NUMBER 1

This Amendment is made by and between the United States Department of Housing and Urban Development (HUD), the Los Angeles Homeless Services Authority (LAHSA), whose business address is 453 S. Spring Street, 12th Floor, Los Angeles, CA 90013, and whose Tax ID number is [REDACTED] and the City of Long Beach (Long Beach) whose business address is 2525 Grand Avenue, Long Beach, CA 90815 and whose Tax ID number is [REDACTED], for Grant Number **CA0522B9D000802**. The Project is the Villages at Cabrillo and it is located at 2001 River Avenue, Long Beach, CA.

RECITALS

1. HUD and LAHSA entered into SHP Grant Agreement CA0522B9D000802 on June 28, 2010 (the Grant Agreement). The Sponsor for the project was the United States Veterans Initiative (U.S. Vets).
2. Under the terms of the grant, the grantee received \$350,396.00 to be used to carry out the project.
3. The grant term was for one year beginning May, 1, 2010 and ending April 31, 2011.
4. In discussions between LAHSA and Long Beach, it was determined that the Villages at Cabrillo project is wholly contained within the Continuum of Care of Long Beach.
5. LAHSA proposed to transfer the grant to Long Beach and in a letter dated April 27, 2010 Long Beach notified HUD that it would accept the grant.
6. In a letter dated October 15, 2010, LAHSA requested that the grant be transferred to the City of Long Beach
7. The site for the project will not change.
8. The project that is funded by grant CA0522B9D060802 will continue to provide the same number of services to the same number of clients.
9. HUD has reviewed the initial application and the proposed change and has determined that, with the change, the application ranking would have been high enough to be competitively selected in the year the application was initially selected.
10. The need for this project and the need for assistance to homeless persons continues within the jurisdiction where the project is located.

11. HUD has reviewed the project and has determined that it should be continued.

The Grant Agreement is hereby amended as follows:

1. The grant will be transferred to the Long Beach Continuum of Care.
2. Grantee for Grant CA0522B9D06000802 will be the City of Long Beach.
3. The City of Long Beach will assume the grant on January 1, 2011.
4. This Amendment to the Grant Agreement constitutes the complete concurrence of the parties as to the amendment of the Grant Agreement.
5. The remaining terms of the Grant Agreement remain in full force and effect.


