AMENDMENT TO CONTRACT NO. 30029

THIS AMENDMENT TO CONTRACT NO. 30029 is made and entered, in duplicate, as of January 20, 2009, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on January 20, 2009, by and between DRESSER, INC. – ROOTS METERS & INSTRUMENTS, dba DMD Dresser. ("Vendor") and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, the parties entered Contract No. 30029 (the "Contract") whereby Vendor agreed to provide certain gas meter equipment to the City of Long Beach; and

WHEREAS, the parties desire to increase the total amount of annual expenditures under the Contract.

NOW, THEREFORE, in consideration of the mutual terms and conditions in the Contract, the parties agree as follows:

1. City is authorized to expend up to \$250,000 annually to Vendor for services rendered under the Contract.
2. The term of the Contract is due to expire on May 1, 2009, and the City has one remaining one-year extension option as described in Section 2 of the Contract.
3. Except as expressly amended herein, all of the terms and conditions of the Contract are ratified and confirmed and shall remain in full force and effect.
