3 THIS FIRST AMENDMENT TO AGREEMENT NO. 29704 is made and  
4 entered, in duplicate, as of February 20, 2009 for reference purposes only, pursuant to a  
5 minute order adopted by the City Council of the City of Long Beach at its meeting held on  
6 May 23, 2006, by and between POST, BUCKLEY, SCHUH & JERNIGAN, INC. WHICH  
7 WILL DO BUSINESS IN CALIFORNIA AS PBS&J, a Florida corporation ("Consultant"),  
8 with a place of business at 625 The City Drive, Suite 200, Orange, California 92868-  
9 4946, and the CITY OF LONG BEACH, a municipal corporation ("City").

10 WHEREAS, the parties entered Agreement No. 29704 and Consultant  
11 agreed to provide As-Needed Multi-Discipline Design Services ("Project"); and

12 WHEREAS, the parties desire to extend the term of the Agreement;

13 NOW, THEREFORE, in consideration of the mutual terms, covenants, and  
14 conditions in this Agreement, the parties agree as follows:

15 1. Section 2 of Agreement No. 29704 is hereby amended in its entirety  
16 to read as follows:

17 "2. TERM. The initial term of this Agreement shall commence at midnight  
18 on June 1, 2006, and shall terminate at 11:59 p.m. on May 31, 2009. The extended term  
19 of this Agreement shall commence at midnight on June 1, 2009, and shall terminate at  
20 11:59 p.m. on May 31, 2010, unless sooner terminated as provided in this Agreement, or  
21 unless the services to be performed hereunder or the Project is completed sooner."

22 2. Except as expressly amended herein, all of the terms and conditions  
23 in Agreement No. 29704 are ratified and confirmed and shall remain in full force and  
24 effect.
