1 AGREEMENT

3 THIS AGREEMENT is made and entered, in duplicate, as of December 23,
4 2020 for reference purposes only, pursuant to Resolution No. RES-20-0169 adopted by
5 the City Council of the City of Long Beach at its meeting on December 15, 2020, by and
6 between GALLS, LLC, a Delaware limited liability company ("Contractor"), with a place of
7 business located at 17600 Fabrica Way, Cerritos, California 90703, and the CITY OF
8 LONG BEACH ("City"), a municipal corporation.

9 WHEREAS, Section 1802 of the Long Beach City Charter permits the City
10 to make purchases under the purchasing contracts of other governmental agencies when
11 authorized to do so by a resolution; and

12 WHEREAS, the City desires to purchase police equipment, supplies, and
13 accessories; and

14 WHEREAS, Contractor has an Agreement with the City of Los Angeles for
15 the purchase of police equipment, supplies, and accessories, Contract No. 59463 ("LA
16 Contract"); and

17 WHEREAS, Resolution No. RES-20-0169 authorizes the City to purchase
18 police equipment, supplies, and accessories by virtue of the LA Contract;

19 NOW, THEREFORE, in consideration of the terms and conditions
20 contained in this Agreement, the parties agree as follows:

21 1. The LA Contract with Contractor, attached hereto as Exhibit "A", is
22 incorporated by this reference as if fully set forth, and the same terms and conditions
23 contained in the LA Contract shall be applicable here except as follows:

24 A. Wherever the LA Contract refers to the City of Los Angeles, it
25 shall be deemed to refer to the City of Long Beach;

26 B. Contractor shall sell, furnish and deliver to the City police
27 equipment, supplies and accessories of substantially the same type and kind
28 purchased under the LA Contract, except as modified by Exhibit "B" attached

1 hereto and incorporated by this reference, in an annual amount not to exceed Five
2 Hundred Thousand Dollars (\$500,000), inclusive of taxes and fees, until the LA
3 Contract expires on November 30, 2021, with the option to renew for three (3)
4 additional one-year periods, at the discretion of the City Manager.

5 C. Payment for the police equipment, supplies and accessories
6 purchased from Contractor by the City shall be made by the City on delivery to and
7 acceptance of the police uniforms and accessories by the City and submittal of an
8 invoice to the City. Payment is due thirty (30) days after the date of the invoice.

9 D. All warranties shall accrue to the City of Long Beach.

10 2. Neither this Agreement nor any money that becomes due to
11 Contractor under this Agreement may be assigned by Contractor without the prior written
12 consent of the City Manager or his designee.

13 3. Any notice given under this Agreement shall be in writing and
14 personally delivered or deposited in the U.S. Postal Service, return receipt, and shall be
15 delivered or mailed to Contractor at the relevant address first stated above, and to the
16 City at 411 West Ocean Boulevard, Long Beach, California 90802 Attn: City Manager.
17 Notice shall be deemed given three days after deposit in the mail.

18 4. The terms appearing on the LA Contract are incorporated in this
19 Agreement.

20 5. Contractor shall cooperate with the City in all matters relating to self-
21 accrual of use tax. Contractor shall contact the City Treasurer for additional information
22 regarding self-accrual.

23 6. This Agreement and all documents which are incorporated by
24 reference in this Agreement constitute the entire understanding between the parties and
25 supersede all other agreements, oral or written, with respect to the subject matter of this
26 Agreement.
