# PROGRESS UPDATE - Accomplishments, Updates and Next Steps see media

Meredith Reynolds, Sustainability Coordinator, provided the following accomplishments and updates:

On February 2, 2010 the Sustainable City Action Plan was approved by City Council and the Sustainable staff is in the final stages of preparing the final document.

The Energy Efficiency Stimulus Funding was approved by City Council on February 16, 2010.

Sustainable staff was awarded a grant in the amount of \$108,000 to plant over 1,000 trees and this will go before the City Council in March for acceptance and recognition.

A few policies are still being prepared such as the Model Landscape Ordinance and Community Gardens. The policies will be presented to the Sustainable City Commission in March 2010.

There is a big push to get prepared for Earth Week which is April 19-24, 2010. There will be a calendar of events as well as a website. Volunteers from Cal State Fullerton will be assisting. Also during Earth Week, the Sustainable staff will produce their first Green Report Card by taking the goals in the Action Plan and documenting their accomplishments.

Everyone is invited to the groundbreaking of Fire Station 12 on March 6, 2010 at 10 a.m.

There are two grant applications coming up in March - the first grant is from Southern California Edison (SCE) for energy efficiency and other energy conservation ideas or proposals to meet the state's Energy Efficiency Long-term Strategic Plan - to determine future needs of the City. The second is a grant from Coca-Cola for recycling bins.

Commissioner Kajer also requested an opportunity in April to have the same video presented to the Sustainable City Commission, if possible.


