FOURTH AMENDMENT TO LICENSE AGREEMENT NO. 33069

THIS FOURTH AMENDMENT TO LICENSE AGREEMENT NO. 33069 is made and entered, in duplicate as of September 23, 2016 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting held on March 5, 2013, by and between CONTE PRODUCTIONS, a California corporation ("Licensee"), and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Licensee entered into Agreement No. 33069 wherein City granted Licensee a non-exclusive revocable license to use the Marina Parking Area for the sole purpose of conducting an arts and crafts market for the sale of arts and crafts items; and

WHEREAS, City and Licensee desire to exercise their fourth and final option to extend the term;

NOW, THEREFORE, in consideration of the mutual terms and conditions in Agreement No. 33069 and herein, the parties agree as follows:

- Section 3 of Agreement No. 33069 is amended in its entirety to read as follows:
- **"**3. Term, Termination and Extension. The initial term of this Agreement shall commence at midnight on February 1, 2013, and shall terminate at 11:59 p.m. on January 31, 2014. The first extended term of this Agreement shall commence at midnight on February 1, 2014, and shall terminate at 11:59 p.m. on January 31, 2015. The second extended term of this Agreement commence at midnight on February 1, 2015, and shall terminate on January 31, 2016. The third extended term of this Agreement shall commence at midnight on February 1, 2016, and shall terminate at 11:59 p.m. on January 31, 2017. The fourth and final extended term of this Agreement shall commence at midnight on February 1, 2017, and shall terminate at 11:59 p.m. on January 31, 2018, unless sooner terminated as provided in this Agreement, or unless the services to be performed hereunder or the Project is completed sooner. Either party may terminate this

Agreement by giving at least thirty (30) d	ays prior notice to the other party as described
below."	
2. Except as expressly	amended herein, all terms and conditions in
Agreement No. 33069 are ratified and con	firmed and shall remain in full force and effect.
