THIRD AMENDMENT TO AGREEMENT NO. 33753

THIS THIRD AMENDMENT TO AGREEMENT NO. 33753 is made and entered, in duplicate, as of December 15, 2017 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on December 2, 2014, by and between PLACEWORKS, INC., a California corporation, with a place of business at 3 MacArthur Place, Suite 1100, Santa Ana, California 92707 ("Consultant"), and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City requires specialized services requiring unique skills to be performed in connection with on-call planning consulting services; and

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 33753 (the "Agreement") whereby Consultant agreed to provide these services; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to increase the total not to exceed Agreement amount to \$800,000; and

WHEREAS, the Parties entered into a Second Amendment to the Agreement to increase the total not to exceed Agreement amount to \$1,250,000 and extend the term; and

WHEREAS, the Parties desire to extend the term an additional one (1) year period;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

1. Section 2 of the Agreement is hereby amended to read as follows:
2. TERM. The term of this Agreement shall commence at midnight on January 1, 2015, and shall terminate at 11:59 p.m. on December 31, 2018, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner.
2. Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 33753 are ratified and confirmed and shall remain in full force
