Meredith Reynolds updated the Commission. Staff is working on logistics and planning for Earth Week 2009. Earth Week is April 20-24th, 2009; Earth Day is April 21st, 2009; Arbor Day is April 24th, 2009. An Earth Week calendar will be coming out shortly. The City of Long Beach just celebrated it's One Year Anniversary of the Bike Share Program. Long Beach Bike Festival and Race will be April 3-4, 2009. The City of Long Beach received notice that we will receive \$4.3 million per year for the next three years towards Energy Efficiency funding through the Stimulus Package. There is a 'Litter Stinks' poster contest currently underway. The City is working with So Cal Edison on a Partnership Program.

Commissioner Greenwood thanked Angie Tam from the Environmental Services Bureau for resolving a trash/recycling issue at 110 Pine Avenue. She recommended a report card for communicating with citizens on achieving goals.

Meredith Reynolds, Sustainability Coordinator, responded that staff is planning to do a report card annually.

Commissioner Greenwood stated that the Wrigley Area Neighborhood Alliance is conducting a tour of the Dominguez Gap Wetlands.

Commissioner Brennan announced a vigil Friday, March 27, 2009 from 5-7 p.m. at Studebaker & Loynes to bring awareness to what happened at these wetlands.

Commissioner Supernaw noted that Councilmember O'Donnell will be a speaker at the vigil. He spoke about the bike element of the Long Beach Marathon and noted that the Pasadena Marathon had a green initiative and included recycling tennis shoes.

Commissioner Kajer encouraged the commissioners to bring their own signs to the vigil on Friday, and said this will be a weekly event. She stated that she attended the Environmental Committee meeting, where a comment was made regarding the Environmental Committee having a closer relationship with the Sustainable City Commission. She asked what the Commission could be doing with the Environmental Committee to foster communication between the two groups.

Meredith Reynolds, Sustainability Coordinator, responded to Commissioner Kajer, stating that staff has met internally on this concern, and noted that at least one staff member will attend the Environmental Committee meetings. She stated that any issues coming out of the Sustainable City Commission will be reported to the Environmental Committee.

Commissioner Kajer asked that the Commission make a formal recommendation on single-use plastics to City Council.

Commissioner Gonzalez spoke about the Sustainable City Commission and understanding their role.

Meredith Reynolds, Sustainability Coordinator, responded that they are working on completing the Chapters, re-establishing a schedule, a report card, and a work plan.

Commissioner White-Kjoss spoke about the first annual Bike Festival in Long Beach on April 3-4, 2009. This festival will feature a professional race and a fashion show. Commissioners can test out bicycle plans in the Bicycle Master Plan and see demonstrations of projects.

Chair Gonzalez thanked the Commissioners for electing her as Chair.
