THIS THIRD AMENDMENT TO AGREEMENT NO. 34211 is made and entered, in duplicate, as of February 27, 2019 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on February 10, 2015, by and between E-PLAN, INC. DBA E-PLANSOFT, a California corporation ("Consultant"), with a place of business at 220 Technology Drive, Suite 110, Irvine, California 92618, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City requires specialized services requiring unique skills to be performed in connection with an Electronic Plan Check System; and

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 34211 (the "Agreement") whereby Consultant agreed to provide these services; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to revise the scope of services and extend the term to February 28, 2018; and

WHEREAS, the Parties entered into a Second Amendment to the Agreement to extend the term to February 28, 2019; and

WHEREAS, the Parties desire to extend the term one (1) additional one-year period;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

1. Section 2 of the Agreement is hereby amended to read as follows:

“2. TERM. The term of this Agreement shall commence at midnight on March 1, 2016, and shall terminate at 11:59 p.m. on February 28, 2020, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner.”

2. Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 34211 are ratified and confirmed and shall remain in full
