FIRST AMENDMENT TO AGREEMENT NO. 33917

3 THIS FIRST AMENDMENT TO AGREEMENT NO. 33917 is made and
4 entered, in duplicate, as of April 25, 2016 for reference purposes only, pursuant to a
5 minute order adopted by the City Council of the City of Long Beach at its meeting on
6 June 2, 2015, by and between RA-DA, a sole-proprietor ("Consultant"), with a place of
7 business at 7523 Norton Avenue, West Hollywood, California, 90046, and the CITY OF
8 LONG BEACH, a municipal corporation ("City").

9 WHEREAS, City requires specialized services requiring unique skills to be
10 performed in connection with as-needed architectural services; and

11 WHEREAS, the parties entered Agreement No. 33917 whereby Consultant
12 agreed to provide these services; and

13 WHEREAS, the parties desire to extend the term and increase the not to
14 exceed Agreement amount;

15 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
16 conditions herein contained, the parties agree as follows:

17 1. Section 1.A. of Agreement No. 33917 is hereby amended to read as
18 follows:

19 "A. Consultant shall furnish specialized services more particularly
20 described in Exhibit "A", attached to this Agreement and incorporated by this
21 reference, in accordance with the standards of the profession, and City shall pay
22 for these services in the manner described below, not to exceed One Million Four
23 Hundred Thousand Dollars (\$1,400,000), at the rates or charges shown in Exhibit
24 "B".

25 2. Section 2 of Agreement No. 33917 is hereby amended to read as
26 follows:

27 "2. TERM. The term of this Agreement shall commence at midnight on
28 July 20, 2015, and shall terminate at 11:59 p.m. on July 19, 2018, unless sooner



1 terminated as provided in this Agreement, or unless the services or the Project is
2 completed sooner. The parties have the option to extend the term for two (2) additional
3 one-year periods.”


4 3. Except as expressly modified herein, all of the terms and conditions
