- 2. The additional work described in the Scope of Work attached to this Amendment as Exhibit "A" is hereby incorporated and included in Scope of Work attached to the Contract as Exhibit "A", and Consultant shall perform such additional work in accordance with the requirements of the Contract.
- 3. Section 1.1 of the Contract is hereby amended so that the total payment by City to Consultant under the Contract shall not exceed \$166,382.
- 4. Except as expressly amended herein, all of the terms and conditions of the Contract are ratified and confirmed and shall remain in full force and effect.

Phase 1 / Task 1a - Develop Monitoring Plan

No change to existing contract, based on M&N letter proposal dated June 22, 2007 for this phase/task.

The additional scope items for this task are:
