3 A RESOLUTION OF THE CITY COUNCIL OF THE  
4 CITY OF LONG BEACH AUTHORIZING THE CITY  
5 MANAGER TO EXECUTE AN AGREEMENT FOR  
6 GRAFFITI REMOVAL SERVICES THROUGH THE  
7 CONTRACT BETWEEN THE COUNTY OF ORANGE AND  
8 GRAFFITI PROTECTIVE COATINGS, INC. FOR AN  
9 ANNUAL AMOUNT NOT TO EXCEED \$ 1,077,600

11 WHEREAS, the Charter of the City of Long Beach (the "City"), Section  
12 1802, permits the City to purchase services, supplies, materials, equipment and labor  
13 with other government agencies by purchasing under their contracts on a voluntary and  
14 selective basis when authorized by resolution; and

15 WHEREAS, the City desires to obtain graffiti removal services for sites  
16 throughout the City of Long Beach and at City park sites; and

17 WHEREAS, the County of Orange has a contract for such graffiti removal  
18 services, Contract No. MA-012-12011805 ("OC Contract"); and

19 WHEREAS, the City's participation in the OC Contract will facilitate  
20 acquisition of graffiti removal services as well as provide considerable cost benefits to the  
21 City; and

22 WHEREAS, if the City had to utilize a formal bid process rather than  
23 participate in the OC Contract considerably more funds would be required;

24 NOW, THEREFORE, the City Council of the City of Long Beach resolves as  
25 follows:

26 Section 1. The above recitals are true and correct and are incorporated  
27 herein by this reference.

28 Section 2. The City Manager of the City is hereby authorized to enter an

1 agreement with Graffiti Protective Coatings, Inc. for Citywide graffiti removal services, on  
2 substantially the same terms as the County of Orange except as modified by mutual  
3 agreement of the City and Graffiti Protective Coatings, Inc., and the purchase by the City  
4 shall be on the same terms and conditions afforded to the County of Orange in a total  
5 amount not to exceed \$ 1,077,600, for a period of one year with the option to extend the  
6 contract for two additional one-year periods.

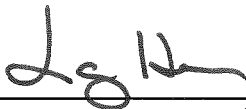
7 Section 3. This resolution shall take effect immediately upon its adoption  
8 by the City Council, and the City Clerk shall certify the vote adopting this resolution.
