LOS ANGELES COUNTY METROPOLITAN TRANSPORTATION AUTHORITY CONTRACT NO. PS95866000LBPD24750, MODIFICATION NO. 7

TRANSIT LAW ENFORCEMENT SERVICES

This Contract Modification No. 7 to Contract No. PS95866000LBPD24750 effective June 30, 2022, by and between the LOS ANGELES COUNTY METROPOLITAN TRANSPORTATION AUTHORITY, hereinafter referred to as "METRO", and the City of Long Beach through Long Beach Police Department (LBPD), hereinafter referred to as the "CONTRACTOR."

WHEREAS, Contractor and Metro entered into Contract No. PS5862300LBPD24750 (previous contract number), effective March 23, 2017, subsequently modified by Modification No. 1, effective January 8, 2018, Modification No. 2, effective October 1, 2019, Modification No. 3 effective August 16, 2021, Modification No. 4 effective January 1, 2022, Modification No. 5 effective July 1, 2022, and Modification No. 6 effective January 1, 2022, hereinafter referred to as the "Existing Contract" and;

WHEREAS, Contractor and METRO desire to amend the Existing Contract as provided herein;

Now, therefore, it is mutually agreed, by and between the parties, as follows:

1. ARTICLE IV.A – CONTRACT PRICE

The not-to-exceed Contract Price of \$36,953,404 shall be increased by \$4,500,000 for a revised not-to-exceed total Contract Price of \$41,453,404.

2. ARTICLE V: CONTRACT TERM AND PERIOD OF PERFORMANCE

Extend the term of the Contract by six (6) months to cover the period July 1, 2022, through December 31, 2022, and change the total Period of Performance to read, March 23, 2017 through December 31, 2022.

3. SP-05 - NON-DISPARAGEMENT

Contractor shall not disparage, denigrate or otherwise negatively characterize the reputation, operations, or administration of LACMTA, including its officers, directors, managers, members, shareholders, partners, owners, employees, agents, successors and assigns. In the event the Contractor breaches this provision, LACMTA reserves the right to terminate this Contract for default.

All other terms and conditions of Contract No. PS95866000LBPD24750 shall remain unchanged.

Except as expressly modified hereby, the Existing Contract, as modified remains in full force and effect as originally executed.
