

1 FOURTH AMENDMENT TO AGREEMENT NO. 34132

3 THIS FOURTH AMENDMENT TO AGREEMENT NO. 34132 is made and
4 entered, in duplicate, as of April 18, 2017, for reference purposes only, pursuant to a minute
5 order adopted by the City Council of the City of Long Beach at its meeting on October 20,
6 2015, by and between JOVENVILLE, LLC DBA WE THE CREATIVE, a California limited
7 liability company ("Consultant"), with a place of business at 2810 Villa Way, Newport
8 Beach, California 92663, and the CITY OF LONG BEACH, a municipal corporation ("City").

9 WHEREAS, City requires specialized services requiring unique skills to be
10 performed in connection with as-needed graphic design and creative services; and

11 WHEREAS, City and Consultant (the "Parties") entered into Agreement No.
12 34132 (the "Agreement") whereby Consultant agreed to provide these services; and

13 WHEREAS, the Parties entered into a First Amendment to the Agreement to
14 increase the amount by \$28,500 for a total not to exceed amount of \$38,500; and

15 WHEREAS, the Parties entered into a Second Amendment to the Agreement
16 to increase the Agreement amount by \$57,400 for a total not to exceed amount of \$95,900;
17 and

18 WHEREAS, the Parties entered into a Third Amendment to the Agreement
19 to increase the amount by \$35,000 for a total not to exceed amount of \$130,900; and

20 WHEREAS, the Parties desire to increase the Agreement amount by \$47,576
21 for a total not to exceed amount of \$178,476;

22 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
23 conditions herein contained, the parties agree as follows:

24 1. Section 1.A. of the Agreement is hereby amended to read as follows:

25 "A. Consultant shall furnish specialized services more particularly
26 described in Exhibit "A", attached to this Agreement and incorporated by this
27 reference, in accordance with the standards of the profession, and City shall pay for
28 these services in the manner described below, not to exceed One Hundred Seventy-
