HONORABLE MAYOR AND CITY COUNCIL City of Long Beach California

RECOMMENDATION:

Adopt a resolution of the City Council of the City of Long Beach adopting a Conflict of Interest Code for the City of Long Beach.

DISCUSSION

The California Political Reform Act requires local governments to adopt conflict of interest codes for elected officials, city officers, employees, advisory board members and consultants. Compliance with the Reform Act is achieved by administration of a Conflict of Interest (COI) program that identifies designated positions and disclosure categories. In turn, designated positions (employees) are required to file Form 700 disclosure forms in three instances: [1] upon assuming office; [2] on an annual basis by April 1st of each calendar year; and [3] upon leaving office. Currently, the COI program involves more than 1,200 filers and is administered by City departments and the City Clerk in a paper based mode.

The recommended action will: [1] streamline the filing process for designated filers, including the ability to store, pull forward, and edit prior year disclosure information; [2] automate and simplify filer compliance and monitoring; [3] establish a "full disclosure" policy for all designated positions; and [4] create the foundation for electronic filing of forms as early as 2011.

SouthTech Systems Incorporated will provide the software that will provide the foregoing benefits; and a brochure highlighting the software functionality of Disclosure Docs and eDisclosure is attached.

TIMING CONSIDERATIONS

Adoption of the recommendation action will allow the City Clerk Department to fully implement the provisions of the attached resolution and a rollout of system software to all City Departments.

FISCAL IMPACT

City Clerk Department FY 2010 Budget funds conduct of this program.







*Electronic Submission with the FPPC is in a three year state pilot program limited to four counties. Following success of the program, Electronic Submission will be open to all organizations.

Filing officials have full access to the status of their agency filers including a complete set of management reports and are empowered to make changes due to filers assuming or leaving positions within their agency. Officials are also provided powerful tools to manage and electronically submit Conflict of Interest Code Amendments.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH ADOPTING A CONFLICT OF INTEREST CODE FOR THE CITY OF LONG BEACH

WHEREAS, California Government Code Section 87300 requires that all public agencies in the State of California must adopt a conflict of interest code; and

WHEREAS, previously the various departments and commissions of the City have adopted individual conflict of interest codes which have been approved by the City Council; and

WHEREAS, the City Council, upon the recommendation of the City Clerk, desires to adopt a single conflict of interest code for all of the departments and commissions of the City;

NOW, THEREFORE, the City Council of the City of Long Beach resolves as follows:

Section 1. The City of Long Beach Conflict of Interest Code, attached hereto as Attachment No. 1, is hereby adopted.

Section 2. All conflict of interest codes previously adopted for City departments and commissions are hereby superseded and of no further force and effect.

Section 3. This resolution shall take effect immediately upon its adoption by the City Council, and the City Clerk shall certify the vote adopting this resolution.

Conflict of Interest Code for the City of Long Beach

The Political Reform Act (Government Code Section 81000, et seq.) requires state and local government agencies to adopt and promulgate conflict-of-interest codes. The Fair Political Practices Commission has adopted a regulation (2 Cal. Code of Regs. §18730) which contains the terms of a standard conflict-of-interest code which can be incorporated by reference in an agency's code. After public notice and hearing, it may be amended by the Fair Political Practices Commission to conform to amendments in the Political Reform Act. Therefore, the terms of 2 California Code of Regulations Section 18730 and any amendments to it duly adopted by the Fair Political Practices Commission are hereby incorporated by reference. This regulation and the attached Exhibits, designating officials and employees and establishing disclosure categories, shall constitute the conflict-of-interest code of the City of Long Beach.
