# PSAC Meeting Locations and Presentations

### Discussion regarding Ammunition Sales Records

Commander Cisneros spoke in favor of ammunition sales records use; and responded to questions.

Chair Hildebrand commended Commander Johnson, Long Beach Police Department, for speaking at the October 10, 2007 PSAC meeting.

Commissioner Quintana requested that public comment be held at this time.

A discussion ensued among the Commissioners and staff.

Commissioner Quintana moved, seconded by Vice Chair Ward, to refer the item to the Public Safety Committee to request from the City Attorney to draft an ammunition sales records ordinance to include the thumbprint; and to work with the retailer Big 5 Sporting Goods to prevent negative impact. Carried by the following vote:

Commissioner Quintana moved, seconded by Commissioner Kavigan, to amend the motion that the item be sent to the Public Safety Committee who could request the City Attorney to draft an ammunition sales records ordinance, using the Tiburon Ordinance as a model, and include the requirement for a thumbprint as part of the ammunition sales records, what should be done with the data, how would the files be kept, what would be the police jurisdiction in looking at the ammunition sales records, and the quantity of ammunition purchased at one time; that City staff work with the Long Beach companies that sell ammunition to refine the ordinance language; and before the ordinance was drafted that the ordinance be submitted to the Public Safety Advisory Commission for review. Carried by unanimous vote.

Commissioner Kavigan submitted a Public Safety Service Commendation form nominating Lisa Massacani, Neighborhood Watch Program Coordinator, a copy of which was received and made part of the permanent record.

Commander Cisneros spoke regarding the budget that was presented to the City Council; advised that crime statistics slightly increased; that the Long Beach Police Department's goal was to decrease overall crimes; and responded to questions.
