FOURTH AMENDMENT TO AGREEMENT NO. 34674

THIS FOURTH AMENDMENT TO AGREEMENT NO. 34674 is made and entered, in duplicate, as of May 2, 2019, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on March 5, 2019, by and between CSG CONSULTANTS, INC., a California corporation ("Consultant"), with a place of business at 3707 West Garden Grove Boulevard, Suite 100, Orange, California 92868, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City requires specialized services requiring unique skills to be performed in connection with as-needed plan review and inspection services; and

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 34674 (the "Agreement") whereby Consultant agreed to provide these services; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to add \$120,000 for a total not to exceed amount of \$200,000; and

WHEREAS, the Parties entered into a Second Amendment to the Agreement to add \$140,000 for a total not to exceed amount of \$340,000; and

WHEREAS, the Parties entered into a Third Amendment to the Agreement to add \$30,100 for a total not to exceed amount of \$370,100; and

WHEREAS, the Parties desire to add \$6,500 for a total not to exceed amount of \$376,600;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

1. Section 1.A. of the Agreement is hereby amended to read as:

"A. Consultant shall furnish specialized services more particularly described in Exhibit "A", attached to this Agreement and incorporated by this reference, in accordance with the standards of the profession, and City shall pay for these services in the manner described below, not to exceed Three Hundred Seventy-Six Thousand Six Hundred Dollars (\$376,600), at the rates or charges
