

1 SIXTH AMENDMENT TO SUBCONTRACT NO. 29347

3 THIS SIXTH AMENDMENT TO SUBCONTRACT NO. 29347 is made and
4 entered, in duplicate, as of June 30, 2011 for reference purposes only, pursuant to a
5 minute order adopted by the City Council of the City of Long Beach at its meeting held on
6 April 19, 2005, by and between BEHAVIORAL HEALTH SERVICES, INC. DBA JOINT
7 EFFORTS, INC., a California nonprofit corporation ("Organization"), with offices located
8 at 505 South Pacific Avenue, Suite 205, San Pedro, California 90731, and the CITY OF
9 LONG BEACH, a municipal corporation ("City").

10 WHEREAS, the City has received monies from Los Angeles County
11 ("County") for City's Family Preservation Program (the "Prime Contract"); and

12 WHEREAS, the City is required to involve community organizations in these
13 services and has selected Organization as a subcontractor under the Prime Contract
14 because Organization provides services required by the Prime Contract; and

15 WHEREAS, Organization agrees to perform said services, to provide City
16 with the information and supporting documentation required herein, and to comply with
17 the Prime Contract; and

18 WHEREAS, the parties desire to extend the term of the Subcontract;

19 NOW, THEREFORE, in consideration of the terms and conditions
20 contained in the Subcontract and this Amendment, the parties agree as follows:

21 1. Section 2 of Subcontract No. 29347 is amended in its entirety to read
22 as follows:

23 "2. The term of this Subcontract shall commence at midnight on August
24 1, 2005 and, unless sooner terminated as provided herein, shall terminate at 11:59 p.m.
25 on June 30, 2012.

26 A. Total disbursements made to the Organization under this
27 Subcontract by City shall not exceed the amounts indicated below, per contract year,
28 provided, however, that if City receives additional funds under the Prime Contract, then

1 this Subcontract may be amended to increase City's disbursements to organization. City
2 shall disburse the funds payable hereunder in due course of payments following receipt
3 from Organization of monthly billing statements in a form approved by City for the
4 preceding month, and conditioned on the City's receipt of the monthly progress report
5 from Organization.

July 1, 2010 – June 30, 2011	\$350,000
July 1, 2011 – June 30, 2012	\$350,000

14 B. The City shall have no obligation to pay Organization until and
15 unless City receives monthly progress reports that summarizes Organization's
16 performance under this Subcontract during the immediately preceding month, and that
17 describes Organization's progress in providing the services stated in Exhibit "A".

18 C. City's obligation to pay Organization arises only after receipt of funds
19 from the County under the Prime Contract.

20 D. Organization shall submit correct and final invoices on a monthly
21 basis. Organization shall prepare and submit monthly invoices within fifteen (15)
22 calendar days after the end of the month in which services were provided. Attached to
23 each invoice shall be documentation to support the invoiced amounts. Failure to submit
24 a completed invoice with proper back-up documentation may result in late payment of the
25 invoice. The City reserves the right to refuse payment of correct and final invoices
26 received sixty (60) days after the services were provided."

27 2. Except as expressly amended in this Sixth Amendment, all terms
28 and conditions in Subcontract No. 29347 are ratified and confirmed and shall remain in

1 full force and effect.

2 IN WITNESS WHEREOF, the parties have executed this Amendment with
3 all formalities required by law as of the date first written above.



DEFINITION OF SERVICES

FAMILY PRESERVATION BASE RATE AND SUPPLEMENTAL SERVICES

Family Preservation Base Rate Services include In-Home Outreach Counseling visits, clinical direction, and the Multidisciplinary Case Planning Committee (MCPC). Family Preservation Supplemental Services include Child Focused Activities, Child Follow-up Visits, Counseling Services, Drug Testing, Emergency Housing, Parenting Training Services/Fatherhood Program, Substance Abuse Assessment and Treatment, Substitute Adult Role Model Services (SARM), Teaching and Demonstrating Homemaker Services (T&D), and Transportation Services. Subcontractor will provide all services in compliance with requirements in the Prime Contract and the Family Preservation Program Statement of Work (Exhibit A-2 of the Prime Contract). Subcontractor will be responsible for all related administrative functions, including but not limited to: all required case documentation and reporting, Family Preservation Archive data collection and data entry, staff training and supervision, Auxiliary Fund requests, and quality assurance activities.
