1 SECOND AMENDMENT TO AGREEMENT NO. 33453

3 THIS SECOND AMENDMENT TO AGREEMENT NO. 33453 is made and
4 entered, in duplicate, as of November 4, 2015, for reference purposes only, pursuant to a
5 minute order adopted by the City Council of the City of Long Beach at its meeting on
6 November 3, 2015, by and between BUNNELL ENTERPRISES, INC. DBA TOTAL
7 NETWORK SOLUTIONS, a California corporation, located at 5150 E. Pacific Coast
8 Highway, Suite 530, Long Beach, CA 90804 ("Contractor"), and the CITY OF LONG
9 BEACH, a municipal corporation ("City").

10 WHEREAS, the City requires specialized services requiring unique skills to
11 be performed on an as-needed basis in connection with professional and technical
12 services for information technology projects and systems; and

13 WHEREAS, the parties entered Agreement No. 33453 whereby Consultant
14 agreed to provide these services; and

15 WHEREAS, the parties desire to extend the term and increase the total not
16 to exceed contract amount;

17 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
18 conditions in this Amendment, the parties agree as follows:

19 1. Section 1.A of Agreement No. 33453 is hereby amended to read as
20 follows:

21 "A. Consultant shall furnish specialized services more particularly
22 described in Exhibit "A", attached to the Agreement and incorporated by this
23 reference, in accordance with the standards of the profession, and City shall pay
24 for these services in the manner described below, a total not to exceed contract
25 amount of Three Hundred Fifty Thousand Dollars (\$350,000), at the rates or
26 charges shown in Exhibit "A"."

27 2. Section 2 of Agreement No. 33453 is hereby amended to read as
28 follows:

1 "2. TERM. The term of this Agreement shall commence on April 22,
2 2014, and shall terminate on January 22, 2017, unless sooner terminated as provided in
3 this Agreement, or unless the services or the Project is completed sooner. The term of
4 the Agreement may be extended for two (2) additional one-year periods.

5 3. Except as expressly modified herein, all of the terms and conditions
6 contained in Agreement No. 33453 are ratified and confirmed and shall remain in full
7 force and effect.

9 executed with all formalities required by law as of the date first stated above.
