This Agreement may be terminated by Client for cause or convenience on two weeks' prior notice without penalty or further obligation after Client has paid for services rendered through the date of termination."
- 3. Except as expressly amended herein, all of the terms, covenants, and conditions of Agreement No. 30110, as amended and to the extent not contrary to this First Amendment, shall remain unchanged and in full force and effect.
