3 THIS FIRST AMENDMENT TO AGREEMENT NO. 29698 is made and  
4 entered, in duplicate as of January 22, 2009 for reference purposes only, pursuant to a  
5 minute order adopted by the City Council of the City of Long Beach at its meeting held on  
6 May 23, 2006, by and between CONCEPT MARINE ASSOCIATES, INC., A DIVISION  
7 OF TRANSYSTEMS CORPORATION, a California corporation ("Consultant"), and the  
8 CITY OF LONG BEACH, a municipal corporation ("City").

9 WHEREAS, the parties entered Agreement No. 29698 and Consultant  
10 agreed to provide As-Needed Multi-Discipline Design Services ("Project"); and

11 WHEREAS, the parties desire to extend the term of this Agreement;

12 NOW, THEREFORE, in consideration of the mutual terms and conditions in  
13 Agreement No. 29698 and herein, the parties agree as follows:

14 1. Section 2 of Agreement No. 29698 is amended in its entirety to read  
15 as follows:

16 "2. TERM. The term of this Agreement shall commence at midnight on  
17 June 1, 2006, and shall terminate at 11:59 p.m. on May 31, 2010, unless sooner  
18 terminated as provided in this Agreement, or unless the services or the Project is  
19 completed sooner."

20 2. Except as expressly amended herein, all terms and conditions in  
21 Agreement No. 29698 are ratified and confirmed and shall remain in full force and effect.






