FIRST AMENDMENT TO AGREEMENT NO. 30220

THIS FIRST AMENDMENT is made and entered, in duplicate, as of March 20, 2008 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on July 10, 2007, by and between LOGIN CONSULTING SERVICES, Inc, a California corporation ("LOGIN"), and the CITY OF LONG BEACH, a municipal corporation ("Client").

WHEREAS, Client and LOGIN entered Agreement No. 30220 on August 14, 2007, wherein LOGIN agreed to provide Client with professional computer services; and

WHEREAS, the parties now desire to extend the term of the agreement;

NOW, THEREFORE, in consideration of the mutual terms and conditions herein, the parties agree as follows:

Section 1 of Agreement No. 30220 is hereby amended in its entirety to read as follows:

"1. <u>AMOUNT</u>: Client agrees to pay LOGIN, TWO HUNDRED AND EIGHT THOUSAND DOLLARS (\$208,000) annually for professional computer services."

Section 2 of Agreement No. 30220 is hereby amended in its entirety to read as follows:

"2. <u>TERM</u>: The term of this Agreement shall commence at midnight on March 12, 2007, and shall terminate at 11:59 p.m. on March 12, 2010. The term of this Agreement may be extended on mutual agreement of the parties and execution of a written amendment to this Agreement. This Agreement may be terminated by Client for cause or convenience on two weeks' prior notice without penalty or further obligation after Client has paid for services rendered through the date of termination."

Except as expressly stated herein, all of the terms, covenants, and conditions of Agreement No. 30220 are ratified and confirmed and shall remain in full force and effect.
