1 EIGHTH AMENDMENT TO AGREEMENT NO. 34678

3 THIS EIGHTH AMENDMENT TO AGREEMENT NO. 34678 is made and  
4 entered, in duplicate, as of July 20, 2021, for reference purposes only, pursuant to a minute  
5 order adopted by the City Council of the City of Long Beach at its meeting on July, 13 2021,  
6 by and between INTERWEST CONSULTING GROUP INC., a Colorado corporation  
7 ("Consultant"), with a place of business at 15140 Transistor Lane, Huntington Beach,  
8 California 92649, and the CITY OF LONG BEACH, a municipal corporation ("City").

9 WHEREAS, City and Consultant (the "Parties") entered into Agreement No.  
10 34678 (the "Agreement") whereby Consultant agreed to provide as-needed plan review  
11 and inspection services; and

12 WHEREAS, the Parties entered into a First Amendment to the Agreement to  
13 add \$120,000 for a total not to exceed amount of \$200,000; and

14 WHEREAS, the Parties entered into a Second Amendment to the Agreement  
15 to add \$30,700 for a total not to exceed amount of \$230,700; and

16 WHEREAS, the Parties entered into a Third Amendment to the Agreement  
17 to add \$70,000 for a total not to exceed amount of \$300,700; and

18 WHEREAS, the Parties entered into a Fourth Amendment to the Agreement  
19 to add \$40,300 for a total not to exceed amount of \$341,000; and

20 WHEREAS, the Parties entered into a Fifth Amendment to the Agreement to  
21 add \$40,000 for a total not to exceed amount of \$381,000 and extend the term to July 31,  
22 2020; and

23 WHEREAS, the Parties entered into a Sixth Amendment to the Agreement  
24 to add \$100,000 for a total not to exceed amount of \$481,000; and

25 WHEREAS, the Parties entered into a Seventh Amendment to the  
26 Agreement to add \$100,000 for a total not to exceed amount of \$581,000 and extend the  
27 term to July 31, 2021; and

28 WHEREAS, the Parties desire to extend the term to October 31, 2021;

1 NOW, THEREFORE, in consideration of the mutual terms, covenants, and  
2 conditions herein contained, the Parties agree as follows:

3 1. Section 2 of the Agreement is hereby amended to read as follows:

4 "2. TERM. The term of this Agreement shall commence at midnight on  
5 August 1, 2017, and shall terminate at 11:59 p.m. on October 31, 2021, unless sooner  
6 terminated as provided in this Agreement, or unless the services or the Project is  
7 completed sooner."

8 2. Except as expressly amended herein, all of the terms and conditions  
9 in Agreement No. 34678 are ratified and confirmed and shall remain in full force and effect.
