EIGHTH AMENDMENT TO AGREEMENT NO. 33917

THIS EIGHTH AMENDMENT TO AGREEMENT NO. 33917 is made and entered, in duplicate, as of March 8, 2023 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on July 5, 2022, by and between RANIA ALOMAR ARCHITECT, INC. DBA RA-DA, a California corporation ("Consultant"), with a place of business at 7523 Norton Avenue, West Hollywood, California, 90046, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 33917 (the "Agreement") whereby Consultant agreed to provide as-needed architectural services in an amount not to exceed Four Hundred Thousand Dollars (\$400,000) for a period of two (2) years with the option to extend the term for three (3) additional one-year periods; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to add One Million Dollars (\$1,000,000) for a total not to exceed amount of One Million Four Hundred Thousand Dollars (\$1,400,000) and extend the term to July 19, 2018; and

WHEREAS, the Parties entered into a Second Amendment to the Agreement to add Five Hundred Thousand Dollars (\$500,000) for a total not to exceed amount of One Million Nine Hundred Thousand Dollars (\$1,900,000); and

WHEREAS, the Parties entered into a Third Amendment to the Agreement to add One Million Three Hundred Thousand Dollars (\$1,300,000) for a total not to exceed amount of Three Million Two Hundred Thousand Dollars (\$3,200,000) and extend the term to July 19, 2019; and

WHEREAS, the Parties entered into a Fourth Amendment to the Agreement to extend the term to July 19, 2020; and

WHEREAS, on June 9, 2020, City Council approved extending the Agreement one (1) additional one-year period; and

1 WHEREAS, the Parties entered into a Fifth Amendment to the Agreement  
2 to extend the term to July 19, 2021; and

3 WHEREAS, on June 8, 2021, City Council approved extending the  
4 Agreement one (1) additional one-year period; and

5 WHEREAS, the Parties entered into a Sixth Amendment to the Agreement  
6 to add Three Hundred Thousand Dollars (\$300,000) for a total not to exceed amount of  
7 Three Million Five Hundred Thousand Dollars (\$3,500,000) and extend the term to July  
8 19, 2022; and

9 WHEREAS, on July 5, 2022, City Council approved extending the  
10 Agreement one (1) additional one-year period; and

11 WHEREAS, the Parties entered into a Seventh Amendment to add Two  
12 Hundred Fifty Thousand Dollars (\$250,000) for a total not to exceed amount of Three  
13 Million Seven Hundred Fifty Thousand Dollars (\$3,750,000), extend the term one (1)  
14 additional one-year period, update the City Representative and attach an updated rate  
15 sheet;

16 WHEREAS, the Parties desire to add One Million Dollars (\$1,000,000) to  
17 the Agreement for a total not to exceed amount of Four Million Seven Hundred Fifty  
18 Thousand Dollars (\$4,750,000);

19 NOW, THEREFORE, in consideration of the mutual terms, covenants, and  
20 conditions herein contained, the Parties agree as follows:

21 1. Section 1.A. of the Agreement is hereby amended to read as follows:

22 "A. Consultant shall furnish specialized services more particularly  
23 described in Exhibit "A", attached to this Agreement and incorporated by this  
24 reference, in accordance with the standards of the profession, and City shall pay  
25 for these services in the manner described below, not to exceed Four Million  
26 Seven Hundred Fifty Thousand Dollars (\$4,750,000), at the rates or charges  
27 shown in Exhibit "B-1".

28 2. Except as expressly modified herein, all of the terms and conditions
