THIRD AMENDMENT TO AGREEMENT NO. 36110

THIS THIRD AMENDMENT TO AGREEMENT NO. 36110 is made and entered, in duplicate, as of May 31, 2023 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on September 7, 2021, by and between JASON ADDISON SMITH CONSULTING SERVICES, INC. DBA JAS PACIFIC, a California corporation ("Consultant"), with a place of business at 201 North Euclid Avenue, Suite A, Upland, California 91786, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City requires specialized services requiring unique skills to be performed in connection with as-needed plan review and inspection services; and

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 36110 (the "Agreement") whereby Consultant agreed to provide these services; and

WHEREAS, the Parties entered into a First Amendment to increase the contract amount to \$600,000; and

WHEREAS, the Parties entered into a Second Amendment to increase the contract amount to \$785,000; and

WHEREAS, the Parties desire to add \$400,000 to the Agreement for a new total contract amount not to exceed \$1,185,000 and extend the term for one(1) additional one-year period;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

1. Section 1.A. of the Agreement is hereby amended to read as follows.
 - "A. Consultant shall furnish specialized services more particularly described in Exhibit "A", attached to this Agreement and incorporated by this reference, in accordance with the standards of the profession, and City shall pay for these services in the manner described below, for the term ending on October 31, 2023, in an amount not to exceed Six Hundred Thousand Dollars (\$600,000); for the term ending on October 31,

1 2023, in an amount not to exceed Seven Hundred Eighty-Five Dollars (\$785,000); for the
2 term ending on October 31, 2024, in an amount not to exceed One Million One Hundred
3 Eighty-Five Thousand Dollars (\$1,185,000), at the rates or charges shown in Exhibit "B".

4 2. Section 2. of the Agreement is hereby amended to read as follows.

5 "TERM. The term of this Agreement shall commence at midnight on
6 November 1, 2021, and shall terminate on October 31, 2024, unless sooner terminated as
7 provided in this Agreement, is unless the services or the Project is completed sooner. The
8 term may be extended for two (2) additional one-year periods, at the discretion of the City
9 Manager."

10 3. Except as expressly modified herein, all of the terms and conditions
11 contained in Agreement No. 36110 are ratified and confirmed and shall remain in full force
12 and effect.
