RECOMMENDATION:

DISCUSSION

On November 10, 2015, the City Council adopted a resolution calling and giving notice of the April 12, 2016 City of Long Beach Primary Nominating Election.

With the close of the candidate nomination period on January 15, 2016, the City Clerk is required to submit the attached resolution for adoption pursuant to City Charter Section 1907, which serves to certify the list of candidates who were duly nominated for City Council Districts Two, Six, and Eight, and identify the order in which their names will appear on the official ballot.

The recommended resolution includes a listing of candidates for contests in the Long Beach Community College District and the Long Beach Unified School District as certified by the Los Angeles County Registrar-Recorder/County Clerk. Candidates for the foregoing contests are listed in the order in which they will appear on the official ballot.

TIMING CONSIDERATIONS

Approval of the recommended action at this time will allow the Office of the City Clerk to prepare the official ballot and sample ballot booklet.

FISCAL IMPACT

The Office of the City Clerk budget contains the appropriations necessary to conduct the April 12, 2016 Primary Nominating Election.

In accordance with Elections Code section 13112(b)(1)(A), the Secretary of State's office conducted a drawing of the letters of the alphabet to determine the randomized alphabet for use in the above election. Listed below is the official order of letters for use in determining placement of candidates' names on the ballot.

Please note that this alphabet is to be applied THROUGHOUT the candidate's entire last name, so if more than one candidate's surname begins with the same letter, the second letter of the surname determines who goes first, according to where the second letter of the name appears in the random alphabet. For example, if two candidates with the surname of Campbell and Carlson are running for the same office, their order on the ballot will depend on the order in which the letters "M " and "R" were drawn in the randomized alphabet drawing.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH DESIGNATING THE BALLOT LISTING OF THE CANDIDATES WHICH HAVE BEEN NOMINATED FOR THE CITY'S PRIMARY NOMINATING ELECTION ON TUESDAY, APRIL 12, 2016

WHEREAS, in accordance with the Long Beach City Charter, the City Council has called a municipal primary nominating election to be held in the City of Long Beach on April 12, 2016, for the City Council offices in Council Districts Two, Six, and Eight, and for the offices of the Board of Trustees of the Long Beach Community College District Two and Four and Board of Education of the Long Beach Unified School Districts Two and Four; and
