RELEASE AND INDEMNIFICATION



Reid Scout Camp located at 4747 Daisy Avenue, Long Beach, CA from July 14, 2012 until August 23, 2012, inclusive.

Except for its gross negligence or willful misconduct, shall indemnify, hold free and harmless, assume liability for, and defend the Boy Scouts of America, Long Beach Area Council, or Scouting's chartered organizations, and any of their affiliates, agents, servants, employees, officers, volunteers, and directors from any and all costs and expenses, including but not limited to, attorney's fees, reasonable investigative and discovery costs, court costs, and all other sums that the Boy Scouts of America, Long Beach Area Council, or Scouting's chartered organizations, and any of their affiliates, agents, servants, employees, officers, volunteers, and directors incur as a result of any demand for claim or assertion of liability under any municipal, state or federal law or cause of action, including any action under the Americans with Disabilities Act, arising or related to the City of Long Beach's agreement with the Long Beach Area Council of the Boy Scouts of America to use the swimming pool at the Will J. Reid Scout Camp located at 4747 Daisy Avenue, Long Beach, CA from July 14, 2012 until August 23, 2012, inclusive..
