SECOND AMENDMENT TO CONTRACT NO. 34715

34715

1 THIS SECOND AMENDMENT TO CONTRACT NO. 34715 is made, and
2 entered into, in duplicate, as of December 28, 2018, for reference purposes only, pursuant
3 to a minute order adopted by the City Council of the City of Long Beach at its meeting held
4 on December 19, 2017, by and between CAREER DEVELOPMENT SOLUTIONS LLC, a
5 California limited liability company with offices located at 1900 S. State College Blvd., Suite
6 100, Anaheim, California 92806 ("Contractor"), and the CITY OF LONG BEACH, a
7 municipal corporation ("City") and administering entity for Pacific Gateway Workforce
8 Investment Network.

10 WHEREAS, City and Contractor (the "Parties") entered into Contract No.
11 34715 whereby Contractor agreed to provide vocational training in various information
12 technology sectors to Pacific Gateway participants; and
13

14 WHEREAS, the Parties entered into a First Amendment of Contract No.
15 34715 to add \$180,000 for a total not to exceed amount of \$450,000; and

16 WHEREAS, the Parties desire to extend the term of the Contract one (1)
17 additional one-year period and add \$150,000 for a total not to exceed Contract amount of
18 \$600,000;

19 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
20 conditions herein contained, the Parties agree as follows:

21 1. Section 2.A of Contract No. 34715 is hereby amended to read as
22 follows:

23 "A. The term of this Contract ("Term") shall be deemed to have
24 commenced as of January 1, 2017, and unless sooner terminated pursuant to the
25 provisions hereof, shall terminate on December 30, 2019. Either of the parties
26 hereto shall have the right to terminate this Contract in its entirety at any time during
27 the Term for any or no reason whatsoever by giving fifteen (15) days prior written
28 notice of termination to the other party. City shall have the additional right to cancel

1 any part of this Contract at any time during the Term for any reason whatsoever by
2 giving fifteen (15) days' notice of such cancellation to the Contractor."

3 2. Section 5.A of Contract No. 34715 is hereby amended to read as
4 follows:

5 "A. The total amount which shall be payable by City to Contractor for
6 Contractor's allowable services during the Term shall not exceed Six Hundred
7 Thousand Dollars (\$600,000)."

8 3. Except as expressly modified herein, all of the terms and conditions
9 contained in Contract No. 34715 are ratified and confirmed and shall remain in full force
10 and effect.
