---

I am submitting the following conditions for an original ABC On-Sale Beer and Wine for bonafide eating place License for Steamed Organic vegetarian Cuisine at 801 East 3<sup>rd</sup> Street.

- No advertising visible from the exterior indicating the availability of alcohol is permitted.
- All alcohol sold on the premises shall be consumed on the premises. Sale of alcohol for consumption off the premises is strictly prohibited.
- Sale of alcohol is permitted only between the hours of 11am and 10pm.
- No bar or lounge for alcohol consumption is permitted
- Full meals must be available at all times alcohol is sold or consumed.
- No "happy hour" type of reduced price alcoholic beverage promotion is allowed.
- Any music shall not be audible from more than 50' outside the premises
- Quarterly gross sales of alcoholic beverages shall not exceed gross sales of food for the same period. Licensee shall maintain records that reflect separately the sales of food and of alcohol.
- There will be no dancing allowed on premises.
- The licensee shall be responsible for maintaining the premises free of graffiti, trash, loitering, or other nuisances.
- No pool, billiards, or gambling machines are permitted on premises.
- The sale of beer or malt in quantities greater than 16 ounces is prohibited.

If any of these conditions are not accepted by ABC Board, all other conditions shall still apply.
