ORDINANCE NO. C-7941

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF LONG BEACH AMENDING THE USE DISTRICT MAP OF THE CITY OF LONG BEACH AS SAID MAP HAS BEEN ESTABLISHED AND AMENDED BY AMENDING A PORTION OF PART 28 OF SAID MAP FROM R-1-N (SINGLE FAMILY RESIDENTIAL) AND I (INSTITUTIONAL) TO P (PARK) FOR PROPERTY LOCATED AT 325 E. PLYMOUTH STREET AND 5346 ELM AVENUE, IN THE CITY OF LONG BEACH (0401-14)

That portion of Part 28 of said map which is amended by this ordinance is depicted on Exhibit "A" which is attached hereto and by this reference made a part of this ordinance and the official Use District Map.
