13 The City Council of the City of Long Beach ordains as follows:

15 Section 1. Environmental documentation having been prepared, certified,
16 received and considered as required by law, and the City Council hereby finding that the
17 proposed change will not adversely affect the character, livability or appropriate
18 development of the surrounding properties and that the proposed change is consistent with
19 the goals, objectives and provisions of the General Plan, the official Use District Map of the
20 City of Long Beach, as established and amended, is further amended by amending a
21 portion of Part 28 of said Map to rezone the subject property from R-1-N (Single Family
22 Residential) and I (Institutional) to P (Park). That portion of Part 28 of said map which is
23 amended by this ordinance is depicted on Exhibit "A" which is attached hereto and by this
24 reference made a part of this ordinance and the official Use District Map.



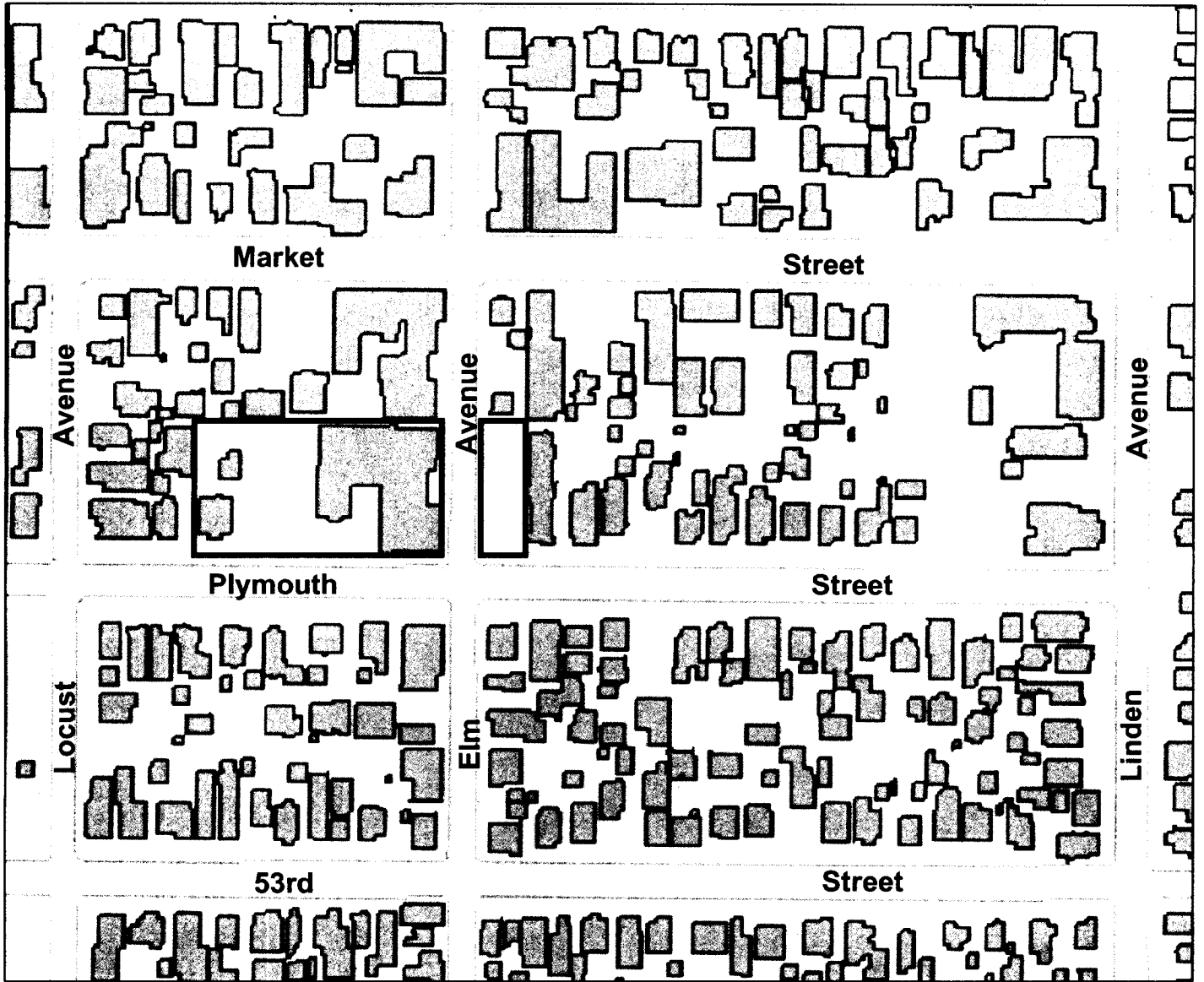
