PROGRESS UPDATES, ACCOMPLISHMENTS & NEXT STEPS FROM SUSTAINABLE CITY STAFF

The following comments were made by Meredith Reynolds, Sustainability Coordinator:

Thanks to Sandra Gonzalez, Planning & Development Bureau Manager, Parks, Recreation and Marine for attending the retreat and providing the overview of the Arroyo Restoration at Rancho Los Cerritos;

Thanks to the staff of Rancho Los Cerritos for providing the location for the retreat;

The Sustainable Staff will be working with the LA County Engery Program (LACEP) to get information and present it to the Sustainable City Commission to get suggestions on informing the public;

Municipal building retrofits (libraries, health facilities, police stations, etc.) are beginning and an update will be presented to the Commission in the months to come; Southern California Edison's audit is moving forward; and

The Green House Gas report for calendar year 2009 will begin soon.

The Low Impact Development Academy is the field project this summer which will begin July 1, 2010. The youth workers will begin July 12, 2010.
