3 A RESOLUTION OF THE CITY COUNCIL OF THE  
4 CITY OF LONG BEACH AUTHORIZING THE CITY  
5 MANAGER TO PURCHASE ONE (1) TYMCO 500X  
6 STREET SWEEPER THROUGH THE CONTRACT  
7 BETWEEN THE CITY AND COUNTY OF SAN FRANCISCO  
8 AND GCS WESTERN POWER & EQUIPMENT

10 WHEREAS, the Charter of the City of Long Beach (the "City"), Section  
11 1802, permits the City to purchase services, supplies, materials, equipment and labor  
12 with other government agencies by purchasing under their contracts on a voluntary and  
13 selective basis when authorized by resolution; and

14 WHEREAS, the City desires to purchase one (1) Tymco 500X Street  
15 Sweeper with the option to purchase additional equipment; and

16 WHEREAS, the City and County of San Francisco has a Contract for the  
17 purchase of this street sweeper from GCS Western Power & Equipment, Contract  
18 Number ITSF07000636/CD ("San Francisco Contract"); and

19 WHEREAS, the City's participation in the San Francisco Contract will  
20 facilitate acquisition of this street sweeper as well as provide considerable cost benefits  
21 to the City; and

22 WHEREAS, if the City had to go to formal bid rather than participate in the  
23 San Francisco Contract considerably more funds would be required;

24 NOW, THEREFORE, the City Council of the City of Long Beach resolves as  
25 follows:

26 Section 1. The above recitals are true and correct and are incorporated  
27 herein by this reference.

28 Section 2. The City Manager of the City is hereby authorized to enter an

1 agreement with GCS Western Power & Equipment to purchase one (1) Tymco 500X  
2 Street Sweeper, with the option to purchase additional equipment, of substantially the  
3 same type and kind purchased by the City and County of San Francisco pursuant to the  
4 San Francisco Contract except as modified by mutual agreement of the City and GCS  
5 Western Power & Equipment, and the purchase by the City shall be on the same terms  
6 and conditions afforded to the City and County of San Francisco in an amount not to  
7 exceed \$232,205.66, including tax, with a 10% contingency for additional equipment, for  
8 a period extending until the warranty on the aerial lift truck expires.

9 Section 3. This resolution shall take effect immediately upon its adoption  
10 by the City Council, and the City Clerk shall certify the vote adopting this resolution.
