RESOLUTION NO. RES-05-0023

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH AUTHORIZING THE CITY MANAGER TO ACQUIRE TEN (10) FIRE PUMPER TRUCKS THROUGH THE CONTRACT BETWEEN THE FIRE DEPARTMENT MOUNT JOY AND SEAGRAVE FIRE APPARATUS, LLC

WHEREAS, the Charter of the City of Long Beach, Section 1802, permits the City to purchase services, supplies, materials, equipment and labor with other government agencies by purchasing under their contracts on a voluntary and selective basis when authorized by resolution; and

WHEREAS, the City of Long Beach desires to purchase ten (10) fire pumper trucks; and

WHEREAS, the Fire Department Mount Joy has a contract for the purchase of these trucks ("Mount Joy Contract"); and

WHEREAS, City's participation in the Mount Joy Contract will facilitate acquisition of these trucks as well as provide considerable costs benefits to the City; and

WHEREAS, if the City had to go to formal bid rather than participate in the Mount Joy Contract considerably more funds would be required;

NOW, THEREFORE, the City Council of the City of Long Beach resolves as follows:

Section 1. The above recitals are true and correct and are incorporated hereby by this reference.

Sec. 2. The City Manager of the City of Long Beach is hereby authorized to enter an agreement with Seagrave Fire Apparatus, LLC. to purchase ten (10) fire pumper trucks of substantially the same type and kind purchased by the Fire Department Mount

1 Joy pursuant to the Mount Joy Contract except as modified by mutual agreement of the  
2 City of Long Beach and Seagrave Fire Apparatus LLC and the purchase by the City of  
3 Long Beach shall be on the same terms and conditions afforded to the Fire Department  
4 Mount Joy in an amount not to exceed \$3,619,090.00 including tax, for a period extending  
5 until the warranty on the trucks expire.


6 Sec. 3. This resolution shall take effect immediately upon its adoption by the
