enter an agreement with McNeilus Truck and Manufacturing, Inc. to purchase three (3) 20-yard rear loaders and six (6) 28-yard automated side loaders of substantially the same type and kind purchased by the District pursuant to the District PO except as modified by mutual agreement of the City of Long Beach and McNeilus Truck and Manufacturing, Inc. and the purchase by the City of Long Beach shall be on the same terms and conditions afforded to the District in an amount not to exceed \$2,059,257 plus tax plus a 10% contingency.

Sec. 3. This resolution shall take effect immediately on its adoption by the City Council, and the City Clerk shall certify the vote adopting this resolution.
