A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH AUTHORIZING THE CITY MANAGER TO ACQUIRE ONE (1) VOLVO L120E WHEEL LOADER TRACTOR THROUGH THE CONTRACT BETWEEN THE U.S. DEFENSE LOGISTICS AGENCY (DEFENSE SUPPLY CENTER PHILADELPHIA) AND MATHEWS MACHINERY, INC.

WHEREAS, the Charter of the City of Long Beach, Section 1802, permits the City to purchase services, supplies, materials, equipment and labor with other government agencies by purchasing under their contracts on a voluntary and selective basis when authorized by resolution; and

WHEREAS, the City of Long Beach desires to purchase one (1) Volvo L120E Wheel Loader tractor; and

WHEREAS, the Defense Logistics Agency (Defense Supply Center Philadelphia) has a contract for the purchase of these Volvo L120E Wheel Loader tractors, Federal Government DSCP Contract No. SP0500-05-D-006 ("DSCP Contract"); and

WHEREAS, City's participation in the DSCP Contract will facilitate acquisition of this Volvo L120E Wheel Loader tractor as well as provide considerable cost benefits to the City; and

WHEREAS, if the City had to go to formal bid rather than participate in the DSCP Contract considerably more funds would be required;

NOW, THEREFORE, the City Council of the City of Long Beach resolves as follows:

Section 1. The above recitals are true and correct and are incorporated herein by this reference.

Sec. 2. The City Manager of the City of Long Beach is hereby authorized to enter an agreement with Mathews Machinery, Inc. to purchase one (1) Volvo L120E Wheel Loader tractor of substantially the same type and kind purchased by the Defense Logistics Agency (Defense Supply Center Philadelphia) pursuant to the DSCP Contract except as modified by mutual agreement of the City of Long Beach and Mathews Machinery, Inc. and the purchase by the City of Long Beach shall be on the same terms and conditions afforded to the Defense Logistics Agency (Defense Supply Center Philadelphia) in an amount not to exceed \$178,443.00 including tax, for a period extending until the warranty on the Volvo L120E Wheel Loader tractor expires.

Sec. 3. This resolution shall take effect immediately upon its adoption by the City Council, and the City Clerk shall certify the vote adopting this resolution.
