Subject: Fund Transfer for Washington Neighborhood Association Holiday Posada

RECOMMENDATION

Increase appropriations in the General Fund Group in the City Manager Department by \$1,250, offset by the First Council District One-time District Priority Funds transferred from the Citywide Activities Department to support the Habitat for Humanity of Greater Los Angeles' support of the Washington Neighborhood Association, Holiday Posada; and,

Decrease appropriations in the General Fund Group in the Citywide Activities Department by \$2,500 to offset a transfer to the City Manager Department.

DISCUSSION

Habitat for Humanity of Greater Los Angeles has been investing in the Washington Neighborhood for years. With their partnership, the Washington Neighborhood Association has continued to form and grow through leadership training and the creation of traditions like the Holiday Posada.

This contribution will allow for the residents of the Washington Neighborhood to create another Posada celebration to be planned and executed safely this holiday season.

Due to the urgency of this item, no financial impact was available.

TIMING CONSIDERATIONS

With only a single meeting happening in December, this item to support the Washington Neighborhood Holiday Posada taking place in late December 2021 must be added to the December 7, 2021 agenda.

FISCAL IMPACT

This recommendation provides District Priority Funds to support the Washington Neighborhood Association Holiday Posada in the First Council District. The appropriation increase of \$1,250 in the General Fund Group in the City Manager's Department, will be offset by a decrease of appropriation of the First Council District One-Time Priority Funds in the General Fund Group in the Citywide Activities Department. The requested action is anticipated to require a minimal

level of staff hours beyond the budgeted scope of duties and is expected to have a minimal impact on existing City Council priorities.
