SECOND AMENDMENT TO CONTRACT NO. 34138

THIS SECOND AMENDMENT TO CONTRACT NO. 34138 is made and entered, in duplicate, as of November 16, 2018, for reference purposes only, pursuant to Resolution No. RES-15-0128, adopted by the City Council of the City of Long Beach at its meeting on October 6, 2015, by and between FORENSIC NURSING SPECIALISTS, INC., a California corporation ("Contractor"), with a place of business at 3373 Cerritos Avenue, Los Alamitos, California 90720, and the CITY OF LONG BEACH ("City"), a municipal corporation.

WHEREAS, the City requires assistance to provide medical examinations, evidence collection, and appropriate treatment with respect to victims of sexual assault; and

WHEREAS, City and Contractor (the "Parties") entered into Contract No. 34138 ("Contract") whereby Contractor agreed to provide medical examinations, evidence collection, and appropriate treatment with respect to victims of sexual assault; and

WHEREAS, the Parties desire to extend the term of the Contract;

NOW, THEREFORE, in consideration of the mutual terms and conditions contained herein, the parties agree as follows:

1. Section 3. of Agreement No. 34138 is hereby amended to read as follows:

"3. The term of this Contract shall be deemed to have commenced on November 1, 2015, and shall terminate at midnight on October 30, 2019 unless sooner terminated as provided in this Contract."

2. Except as expressly modified herein, all of the terms and conditions contained in Contract No. 34138 are ratified and confirmed and shall remain in full force and effect.
