17	1. Contractor shall sell, furnish, and deliver to City materials listed on Exhibit

20	2. The notice inviting bids and Contractor's Bid are incorporated by this			
21	reference. These documents together with this Agreement constitute the contract between

23	3. City shall pay to Contractor for the materials the prices set forth on Exhibit			
24	"A" attached to this Agreement and incorporated by this reference.			
25	The foregoing prices do not include federal excise tax from which			
26	municipalities are exempt, and none shall be charged to the City. California sales or use			
27	taxes, or any municipal or county sales taxes shall be added where applicable.

Payment shall be made in due course of payments of the City after
 delivery of the materials and receipt of an invoice from Contractor.

5. Any notice shall be in writing and personally delivered or deposited in the
U.S. Postal Service, first class, postage prepaid, to Contractor at the address first stated
above, and to the City at 333 West Ocean Boulevard, Long Beach, California 90802 Attn:
City Manager. Notice of change of address shall be given in the same manner as stated
for other notices. Notice shall be deemed given on the date deposited in the mail or on the
date personal delivery is made, whichever occurs first.

6. Neither this Agreement nor any of the moneys which may become due to
 Contractor under it may be assigned by Contractor without the prior written consent of the
 City.

7. The acceptance of materials by the City or the payment of any money by
the City shall not operate as a waiver of any provision of this Agreement, or of any power
of the City, or of any right to damages. The waiver of any beach or default shall not be
held to be a waiver of any other or subsequent breach or default.


