RESOLUTION NO. RES-12-0044

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH AUTHORIZING THE CITY MANAGER TO PURCHASE FIVE BMW POLICE CERTIFIED MOTORCYCLES THROUGH THE PURCHASE ORDER BETWEEN THE LOS ANGELES COUNTY SHERIFF'S DEPARTMENT AND R.C.A. INVESTMENTS, INC. DBA LONG BEACH BMW MOTORCYCLES

WHEREAS, the Charter of the City of Long Beach (the "City"), Section 1802, permits the City to purchase services, supplies, materials, equipment and labor with other government agencies by purchasing under their contracts on a voluntary and selective basis when authorized by resolution; and

WHEREAS, the City desires to purchase five (5) BMW police certified motorcycles; and

WHEREAS, the Los Angeles County Sheriff's Department has a Purchase Order for the purchase of these BMW motorcycles, Purchase Order No. PO-SH-12321526-1 ("LACS PO"); and

WHEREAS, the City's participation in the LACS PO will facilitate acquisition of these BMW motorcycles as well as provide considerable cost benefits to the City; and

WHEREAS, if the City had to go to formal bid rather than participate in the LACS PO considerably more funds would be required;

NOW, THEREFORE, the City Council of the City of Long Beach resolves as follows:

Section 1. The above recitals are true and correct and are incorporated herein by this reference.

Section 2. The City Manager of the City is hereby authorized to enter an

1 agreement with R.C.A. Investments, Inc. dba Long Beach BMW Motorcycles to purchase
2 five (5) BMW police certified motorcycles of substantially the same type and kind
3 purchased by the Los Angeles County Sheriff's Department pursuant to the LACS PO
4 except as modified by mutual agreement of the City and R.C.A. Investments, Inc. dba
5 Long Beach BMW Motorcycles, and the purchase by the City shall be on the same terms
6 and conditions afforded to the Los Angeles County Sheriff's Department in an amount not
7 to exceed \$136,400, including tax and shipping, for a period extending until the warranty
8 on the BMW police certified motorcycles expires.


9 Section 3. This resolution shall take effect immediately upon its adoption
10 by the City Council, and the City Clerk shall certify the vote adopting this resolution.
