Lighting Contract (24289), dated November 21, 1995, by and between WS Light & Power, Inc. (as successor in interest to City Light & Power, Inc.), a California corporation (the "Company"), and the City of Long Beach, a California municipal corporation ("you" or "your"), as amended (the "Agreement").

Dear Sir or Madam:

We are pleased to announce that City Light & Power, Inc., a Nevada corporation, and CLP Holdings, Inc., a California corporation, the owner of all of the outstanding stock of the Company (together, "CLP"), and their respective stockholders have entered into a definitive agreement with Hunt Amber CLP Ownership, LLC, a Delaware limited liability company ("Buyer"), pursuant to which (i) Buyer will acquire a majority of the outstanding stock of CLP, and (ii) Buyer and certain CLP stockholders will collectively contribute 100% of the outstanding stock of CLP to a parent company to be formed prior to the closing of the Transaction (collectively, the "Transaction"), which is currently expected to occur in the first calendar quarter of 2020. Although the Transaction will result in a change in the indirect ownership of the Company, CLP Holdings, Inc. will continue to own 100% of the outstanding stock of the Company. Following the consummation of the Transaction, the Company is expected to continue its normal business operations.

Under the terms of the Agreement, the Transaction may constitute a change of control requiring your consent and, accordingly, this letter is being delivered to you to request your acknowledgment, agreement, and consent that: (i) the consummation of the Transaction will not constitute a default, breach or termination event of or under the Agreement, (ii) the Agreement will remain in full force and effect, unmodified, immediately following the consummation of the Transaction, (iii) you are hereby waiving any rights under the Agreement that may apply with respect to the Transaction, (iv) all notice requirements under the Agreement with respect to this letter (including requirements as to form of delivery and notice, time requirements and otherwise) have been complied with (or are hereby waived), and (v) you are hereby authorizing CLP, the Company and Buyer to rely on the consent set forth herein and agree that such consent shall inure to the benefit of and shall be enforceable by the foregoing parties and their respective successors and permitted assigns.

We ask that you confirm your acknowledgment and agreement of, and consent to, the matters set forth in this letter by countersigning this letter on the signature line provided below, and return the executed letter via email to the following address: mwm@clpinc.com.
