WHEREAS, the Legislature and Governor of the State of California have approved a grant for the project shown above; and

WHEREAS, the California Natural Resources Agency has been delegated the responsibility for the administration of the grant project, setting up necessary procedures; and

Resources Agency require the Grantee to certify by resolution the approval of a Project
Information Package before submission of said package to the State; and

WHEREAS, City of Long Beach ("Applicant") desires to enter into an agreement with the State of California and accept grant funds from the California Natural Resources Agency for capital improvements at Wrigley Greenbelt Restoration Project and Multi- Service Center Expansion and Improvements Project ("Project"); and

WHEREAS, if awarded, Applicant intends to accept an amount up to Five Million Two Hundred Thousand Dollars (\$5,200,000) for completion of the Project and authorize the City Manager, or designee, to execute all documents necessary to accept the funds and implement the project;
