RECOMMENDATION:

Adopt the attached Resolution authorizing the City Manager to execute a contract and any amendments thereto with McNeilus Truck and Manufacturing for the purchase of one McNeilus liquefied natural gas (LNG) powered rear loader refuse truck on the same terms and conditions afforded the City of Lompoc in the total amount not to exceed \$240,992 including tax, with the option to purchase additional units, plus a 10 percent contingency if necessary and if funds are available. (Citywide)

DISCUSSION

City Council approval is being requested authorizing the City Manager to execute a contract for the purchase of one McNeilus LNG rear loader refuse truck for the Department of Public Works, Environmental Services Bureau, Refuse Division.

The Department of Public Works, Fleet Services Bureau, is requesting to purchase one LNG powered rear loader refuse truck as part of the Fiscal Year 2008 (FY 08) purchase plan. This new truck is a smaller design for use in narrow alleys and where overhead clearance is a problem. This rear loader will be used to support the newly formed Clean Long Beach Program in concert with a new refuse truck for the Alley Clean Up Program. These Programs endeavor to remove litter in the alleys of Long Beach, and increase the awareness of the City's litter removal program among the residents of the City of Long Beach.

The City Charter provides an alternative procurement method by permitting the City to purchase or otherwise obtain services, supplies, materials, equipment and labor with other governmental agencies by purchasing under their contracts on a voluntary and selective basis when authorized by a Resolution of the City Council.

The Department of Public Works, Fleet Services Bureau, investigated procurement options and learned that the City of Lompoc had completed a competitive bid process in October 2007 for rear loader refuse trucks and has a contract with McNeilus Truck and Manufacturing that meets the City's needs. This cooperative purchase agreement will facilitate the timely acquisition of this refuse truck and provide cost benefits to the City.

McNeilus Truck and Manufacturing has agreed to sell one McNeilus LNG rear loader refuse truck to the City of Long Beach under the same terms and conditions as are afforded to the City of Lompoc. The Matrix Fleet Review Study also supports the use of cooperative purchase agreements and adherence to a long-term replacement plan.

This matter was reviewed by Deputy City Attorney Amy R. Burton on August 12, 2008 and Budget Management Officer Victoria Bell on August 18, 2008.

TIMING CONSIDERATIONS

City Council action to adopt the attached Resolution is requested on September 9, 2008 to ensure that the contract is in place expeditiously to minimize delivery turnaround time.

FISCAL IMPACT

The cost of this contract is \$240,992 including tax, and is budgeted in the Fleet Services Fund (IS 386) in the Department of Public Works (PW). Costs will be recovered from the Refuse Fund (EF 330) in the Department of Public Works (PW). The City will have the option of purchasing additional units, and adding expenditures up to 10 percent (or \$24,099) above the contract amount, if necessary and if funds are available.



5 MANAGER TO PURCHASE ONE (1) MCNEILUS LNG
6 POWERED REAR LOADER REFUSE TRUCK THROUGH
7 THE PURCHASE ORDER BETWEEN THE CITY OF

11 WHEREAS, the Charter of the City of Long Beach (the "City"), Section
12 1802, permits the City to purchase services, supplies, materials, equipment and labor
13 with other government agencies by purchasing under their contracts on a voluntary and
14 selective basis when authorized by resolution; and

15 WHEREAS, the City desires to purchase one (1) McNeilus liquefied natural
16 gas (LNG) powered rear loader refuse truck with the option to purchase additional units,
17 plus a ten percent contingency if necessary; and

18 WHEREAS, the City of Lompoc issued an invitation to bid for the purchase
19 of this LNG powered rear loader refuse truck from McNeilus Truck and Manufacturing
20 Co., and entered into Purchase Order No. P402428 ("Lompoc PO") for the purchase of
21 the truck; and

22 WHEREAS, the City's participation in the Lompoc PO will facilitate
23 acquisition of this LNG powered rear loader refuse truck as well as provide considerable
24 cost benefits to the City; and

25 WHEREAS, if the City had to go to formal bid rather than participate in the
26 Lompoc PO considerably more funds would be required;

27 NOW, THEREFORE, the City Council of the City of Long Beach resolves as
